LICENCE CONDITIONS

The granting of this licence is subject to the following conditions:

- 1) Portapa 2 (Pty) Ltd must have legal possession of all premises specified in this licence, including the URL. Furthermore, all online and land-based facilities must be kept safe, secure and in good working order.
- 2) Portapa 2 (Pty) Ltd shall provide to the Mpumalanga Economic Regulator (MER), guarantees as determined by the MER from time to time, for liabilities of Portapa 2 (Pty) Ltd in relation to: betting levies payable, and betting debt payable by Portapa 2 (Pty) Ltd. The guarantees shall be maintained at such levels as may be determined by the MER from time to time.
- 3) Portapa 2 (Pty) Ltd shall submit to the MER periodically as stipulated by the MER from time to time, a deliverable report containing all information required in the format approved by the MER.
- 4) Portapa 2 (Pty) Ltd shall ensure that internal control procedures of the company are submitted to the MER prior to commencement of operations and adhered to.
- 5) Portapa 2 (Pty) Ltd shall on a continuous basis, satisfy the MER of sufficient measures taken to ensure that no persons under the age of 18 years have access to any online and land-based betting facilities authorised in terms of this licence.
- 6) Portapa 2 (Pty) Ltd shall have an electronic record keeping system, certified in terms of applicable South African National Standards (SANS) and approved by the MER, with access to the system provided and maintained for the MER, at the cost of Portapa 2 (Pty) Ltd.
- 7) Portapa 2 (Pty) Ltd must ensure that they have legal rights to conduct betting activities on sporting events or other contingencies, where applicable. Furthermore, all contingencies offered on online and land-based betting facilities authorised in terms of this licence must be approved by the MER.

- 8) All wagering or betting equipment, software, online links or feeds and data warehousing must be supplied and maintained by holders of certificates of suitability or licensed manufactures, suppliers, and distributors, unless a bookmaker uses and maintain its own systems.
- 9) The approved URL must have a visible link on the landing page to a copy of this licence certificate, as approved by the MER from time to time.
